<u>Instructions</u>: This form is for licensees to keep a record of the required continuing education for license renewal. Please update this form each time a CEU is completed and attach a copy of proof of having completed each CEU. The licensee will need to keep this in their files for use when the license is renewed. Each renewal season you will be notified when to send this form and supporting documents into the Board office.

<u>Requirements</u>: Each licensee is required to complete sixteen (16) hours of continuing education units (CEU's) over the two-year licensure period. Of these required hours, two (2) hours in Ethics will be required over the two (2) year licensure period. Initial licensure periods, which are less than two (2) years, will be prorated for eight (8) CEU's if the licensure period is one year or less. Of these required hours, one (1) hour in Ethics will be required. Please refer to CHAPTER 741-X-7 — Continuing Education in the Rules and Regulations of the Board for detailed information.
